One third of its members are elected while two thirds are appointed to ensure that all colleges are represented in the Council, provided that the number of Council representatives from each college does not exceed (3). <br> - The membership of the student Council is subject to the following: <br> - To be a regular, full time student. <br> - To hold a good reputation. <br> - The student's record must be lacking any penalties or disciplinary warnings. |
